- Identify and provide resources needed to obtain optimum efficiency in delivering the required service,
- Determine, plan, carry out and monitor service realization processes,
- Define and implement control, analysis and improvement processes as means of ensuring that service conforms to specified requirements.

We, the management of the operation & maintenance department, are fully committed to ensure that this policy is scrupulously and efficiently communicated to all levels of the organization, permanently applied throughout the entire department, and that the related Quality Management System satisfies the ISO 9000 standard requirements.



HEALTH & SAFETY



The following plan is presented to indicate Safety Policy and scope of training offered by Al-Mashrik to maintain a vigorous accident prevention programme, thereby eliminating human distress and financial loss. We place great emphasis on this comprehensive programme which will be aggressively carried out throughout all levels of the company. The programme is administered by the Safety Officer, Safety Assistants and a Male Nurse.

The Al-Mashrik Organization's primary area of emphasis is on accident prevention. Knowledgeable and safety conscious employees utilizing good techniques and equipment are the cornerstone of the company's accident prevention policy. Accidents can be avoided by using good judgment and common sense. Our work force and supervisors are fully conversant with the recognition of hazards associated with their jobs and we insist that our employees work safely by complying with the necessary precautions. Our accident prevention scheme includes training and education too. Each new arrival in the company receives a safety indoctrination course administered by the Safety Officer which includes the proper use of protective equipment and outline of hazards which may be encountered on a particular job and a discussion on the individual responsibility in avoiding injury or damage, fire prevention with a demonstration of operating fire extinguishers, the rendering of primary first aid and the established driving policy.

We plan all projects to insure that they will be carried out with a high degree of safety for all concerned and that our work will be safe and productive. Our vital interest is to follow the established Al-Mashrik safety standards and methods of enforcing them, to ensure safe and healthy working conditions and to preserve human resources. All members of our management and supervisors of all grades are well aware that safety must take equal importance with cost and construction and that they have a moral and legal responsibility to follow standards as laid down for the project and Saudi Arabian law.

Our company Safety Officer and his assistants are responsible for achieving our goal of "NO ACCIDENTS" by conducting weekly safety meetings to improve existing work methods, daily jobsite inspections to recognize any unsafe condition and to insure that legal and contractual requirements affecting safety and health are complied with. The Safety Officer is also responsible for the investigation of any injury to personnel or loss or damage to equipment and material and to compile a monthly safety report. Prior to commencement of work arrangements will be made for first aid facilities to allow prompt attention to the injured in accordance with Saudi Arabian law.

+ P O L I C I E S I

It is the Policy of AI-Mashrik Company, wherever it conducts activities and business, to ensure that strict operational procedures are identified to give proper regard to the conservation of the environment. In implementing this Policy AI-Mashrik Company fully recognize the importance of complying with the requirements of relevant local legislation and also promoting the appropriate measures to safeguard the environment for all whom may be affected directly or indirectly by the Company's operational activities.

The appropriate measure relate to the safety of operations undertaken by the Company's employees and sub-contractors. This includes the prevention of air, water and soil pollution, as well as the necessary precautions to minimize damage from accidents that may occur in the circumstances. The Company undertakes to continually review and seek to improve its operating procedures, equipment and other resources to comply with the following Environmental Policy:

All Company Employees will observe applicable environmental, health, hazardous material transportation and safety laws & regulations. Priority will be given to the protection of employees, the public, clients and the environment. Prior to any new or changes to existing operations the Company's line management will address any possible adverse environmental impacts before their implementation. The environmental impact of all materials in use or proposed for use in operations will be assessed in advance.

Strict control by line management responsible for operations shall be exercised on waste generation and onsite disposal together with toxic and critical pollutant emissions. Materials, which are considered of a hazardous nature to the employee, public or the environment shall be avoided, but, where their use is deemed necessary use shall be minimized. However, wherever possible such materials shall be replaced by alternative materials of an environmentally friendly nature.

Work activities shall be planned carefully to ensure that spills and unintended releases to the environment are avoided. The Company, through its line management, will promote environmental concern among its employees and seek to generate an overall awareness of the impact of their operational activities on the environment. All employees will be further encouraged to identify and promptly report potential environmental matters of concern to their senior management and / or the health, safety section.

The Company having acknowledged the importance of protecting the environment, will at all practical times seek to promote the efficient use of energy sources and maximize on conservation aspects.


